# Minutes of the meeting of Weeley Parish Council held on 22<sup>nd</sup> April 2025

- **01/25.1** Apologies: No apologies were received.
- 01/25.2 Minutes of the previous meeting: The minutes of the Parish Council meeting held on 17<sup>th</sup> March 2025 were proposed by Cllr Botterell, seconded by Cllr Millar and it was RESOLVED: To approve the minutes of the Parish Council meeting held on 17<sup>th</sup> March 2025 as an accurate record of proceedings.
- **Declarations of Interest**: Cllr Botterell declared an interest in item 01/25.10 as his company provided a quote. Cllr T. Spong declared an interest in an item in the payments list.
- **Clerk's Report**: The Clerk presented the previously circulated report attached as Appendix A. All Councillors confirmed they had read the report and there were no questions.
- **01/25.5 Public Participation**: The Chair invited the members of public in attendance to raise any questions/issues.

# 01/25.6 Tendring District and Essex County Councils:

TDC CIIr Harris: mentioned the following:

- The Local Plan first consultation was now complete. The final decision will be next January or February.
- Weeley Offices which have been empty for 5 years will now be looked at again to see what options there are other than demolition. We should find out within 3 months.

### EALC CIIr Land: mentioned the following:

- He will stay in office as elections have been postponed by Government.
- Summary of good works done during his tenure including Landermere Road, Thorpe High Street, The Street Little Clacton, Roundabouts at Thorpe Road. The dip between Thorpe le Soken and Weeley, Welcome to Weeley signs and that pavements in Weeley Heath to be done very soon.
- Colchester Road was a negative but he will continue to pursue this
- He has been able to support the Parish Council / WIB and WRA with grants
- 01/25.7 Telephone Library: Cllr, Green informed council that the Telephone Library should be installed soon. The clerk informed that we now have a lease on the land for the Phone Box for one year currently. The quote for works was previously circulated and Cllr. Hamilton proposed and Cllr. Beady seconded and it was RESOLVED to accept the quote and agreed to install telephone box with shelves once concrete has been laid.
- 01/25.8 Weeley Bypass: The report from ECC Place Services was discussed and it was agreed to investigate costs etc to replace 13 trees with different coloured Acers. It was considered that the ornamental cherry trees were nice but too short lived. Cllr. Green to provide costs for 3 metre trees. Cllr. Hamilton proposed and Cllr. Botterell seconded and it was RESOLVED to purchase and install 13 trees. Action: Clerk (to investigate grants)
- **01/25.9 Insurance:** Clerk provided details of the newly agreed insurance for the next 3 years.
- **01/25.10 CCTV Upgrade:** Council discussed options and it was decided to upgrade the existing equipment around the Village Hall and also to install a camera at Station Approach. Cllr. Spong proposed and Cllr. Hamilton seconded and it was **RESOLVED** to upgrade the CCTV equipment. **ACTION: Clerk to get more quotes**
- **01/25.11 Memorial Bench:** as per 12/25.11 the clerk presented findings and Cllr Botterell proposed and Cllr Hamilton seconded and it was **RESOLVED** to install a memorial bench near the Petanque area with 2 trees nearby. Engraving to be 'Dedicated to the Memory of Cllr Mike Brown / 1945 to 2023' as per Cllr Fitzpatrick. **ACTION: Clerk**
